# **COVID-19 HEALTH ORDER AND VACCINATION CLINICS**

The LA County Health Order ("Health Order") requires that ALL EMPLOYEES, VOLUNTEERS, PHYSICIANS, and other HEALTH CARE PROFESSIONALS provide proof of the COVID vaccine or a declination of the COVID vaccination **before November 1**, **2023**.

*If you decline the updated COVID-19 vaccine you must submit a completed declination form by November 1, 2023.* If you decline the vaccine for any reason, you must wear a mask for the entirety of the respiratory illness season (November 1, 2023, to April 30, 2024). The COVID-19 masking mandate is in addition to the current Torrance Memorial masking guide-lines and expands beyond patient care areas. Unvaccinated HCP will be required to wear a mask at all times and in all locations. Your decision to decline the vaccine will not affect your privileges.

Only **64%** have received their vaccine or submitted form. We need to have **100%** response by November 1. Even if you plan to receive the vaccine after November 1, you still need to fill out the form.

If you do not get the COVID vaccine, you will be required to wear a mask in all areas at all times (other than when eating or drinking).

Upon vaccination, a verification sticker will be added to our badge

\*Those who have received the previous bivalent COVID-19 vaccine within the last two months (on or before 9/14/23) will not be eligible to receive the updated COVID-19 vaccine at this time. Once the two-month period has passed, those employees will be required to comply with the Health Order and either receive the 2023-24 COVID-19 vaccine or sign declination form.


