


What's happening?

Torrance Memorial Home Health and Hospice will be transitioning to a new electronic health record called MatrixCare on April 1st, 2023.

MatrixCare integrates with Cerner Millennium.

What to expect?

- Ordering Providers will begin receiving TMMC Home Health and Hospice Orders, Plan of Care, and Transfer Summaries in their Cerner Message Center Inbox under Documents. These documents can be signed from within the inbox and sent back to MatrixCare electronically.
- Signed orders and documents will be saved in the Cerner health record and can be viewed under Documents or Document Viewer.

INFORMATIONAL

Due to a recent possible prion exposure of Creutzfeldt-Jakob disease (CJD), changes have been made to the order set. The current CJD Panel order will test for the following in a CSF Sample:

- 14-3-3 protein
- Tau
- RT-QuIC (Real Time Quaking Induced Conversion)

Although the order indicates only 14-3-3 will be tested, all 3 tests mentioned above are performed.

The lab will send the CJD panel to ARUP. ARUP sends CJD panel to Case Western's National Prion Disease Pathology Surveillance Center. Neuron-Specific Enolase (NSE) is no longer part of the CJD Panel. The Mayo Clinic now only performs Neuron Specific Enolase for CJD.
