

What started as a superficial scratch 51year-old Oscar Gallardo made on his left toe last June while swimming in a pool turned out to be so much more. After several days of self-care, he noticed discoloration at the scratch site had spread throughout his forefoot. Having underlying diabetes since childhood, he became concerned and made an appointment to see his physician. He was told not to worry, was treated with creams and told not to wear shoes to give his foot a chance to heal. After nearly five months of treatment, an infection developed. He feared he would lose his entire foot. At this point, he sought help at Torrance Memorial's Burn, Wound Healing and Amputation Prevention Center - where he found life and limb-saving care. "From the moment I met Dr. Karen Shum, I told her I would do anything to save my foot," said Gallardo.

Dr. Shum quickly diagnosed a vascular blockage previously missed, which prevented his healing. A vascular procedure was done to clear the vessel blockage. Dr. Shum told him a transmetatarsal amputation to remove the

infected toes, was necessary. She would try to preserve as much of his foot as possible to enable ambulation with a functional limb. From proper diagnosis and problem-solving to surgery, Gallardo found the care at Torrance Memorial to be very good and personal. "I found the confidence I needed and received life-saving care," said Gallardo. The team at Torrance Memorial gave him the reassurance that he was finally getting the right care. Dr. Shum even arranged for state-of-the-art hyperbaric oxygen therapy to prevent further infection and promote healing. Gallardo is now making a full recovery.

He was also inspired to make personal lifestyle changes by exercising routinely and improving his diet. Today, he has lost nearly 65 lbs. and feels like he has his life back – not to mention the preservation of his left foot. Gallardo has been able to return to work and credits the team at Torrance Memorial Wound Healing and Amputation Prevention Center for saving his foot and enabling him to walk again.

#### **User Lever Preferences and the Problem List**

Hello all,


As your Executive Director of Medical Informatics, I am your physician liaison to all things Cerner Millennium. With an experienced team of informaticists and service specialists supporting me, we are available to assist you with questions or ideas regarding use of the electronic medical record across both the acute and ambulatory locations of the Torrance Memorial Health System.

We have recently installed a function called User Level Preferences. This helps with customization of the Consolidated Problem List. The Consolidated Problem List is the mainstay of the Cerner electronic medical record. It shares all the information about your patient's current and past medical conditions, procedures and diagnosis. It identifies ICD-10 codes and Hierarchical Condition Categories. Informatics and Quality and Patient Safety use the problem list for required reporting to CMS and other state and national registries and which helps to maintain our national ranking. We can use the problem list for research databases, tracking of infectious disease and studying treatments. The most important thing about the problem list it its effective communication between providers and member of the patient care team in one place and in one glance.

User Level Preferences allows you to customize the problem list. For example, your patient presents to the Emergency Department. As an outpatient, the primary care provider has already entered the patient's history, so the ED physician knows the patient's past medical history at a glance. These problems are under chronic conditions. The ED provider enters their acute conditions in a numbered list:


Left hip fracture
 Acute kidney injury
 Uncontrolled Hypertension
 Sepsis

Now, our hospitalist admits the patient, but wants a different priority. They will see the list without numbers, and can assign the numbers to their preference:




#### **Medical Informatics**

Now, here comes our Cardiology Consultant. They need to clear this patient for surgery. They can also reorder the hospitalists list:



And so on! The preference of the list will now stay the same for each user and copy over to the note. No need to reorder the list each time. Additional diagnoses will show at the bottom of the list, available to be added at any time.

# Implementing Automated Phone Tree

The TMMC Emergency Department will be implementing an automated phone tree on October 1, 2021 for (310)517-7070, Ext 22456. This will direct non urgent calls away from the unit secretaries so they are available to answer physician and physician office calls faster. To reach the unit secretary immediately, press 1 as soon as the call connects, it is not necessary to listen to the prompt. We appreciate your understanding and adjustment for this improvement.

#### **OVERVIEW**

The Emergency Department (ED) is a chaotic environment where its team is constantly triaging and evaluating the urgencies of presenting problems. The ED Unit Secretary (US) is critical to the successful flow of the department. They field critical calls between physicians and deliver time sensitive information through the hospital and community.

#### **SITUATION**

The Torrance Memorial Medical Center (TMMC) USs are wearing a multitude of hats. Currently they answer every incoming call then triage them quickly to the best of their ability. The US answers these calls while tending to their other tasks which include scanning paperwork and making outgoing calls for the physicians, physician assistants, nurses, social workers and case managers.

Incoming calls are not triaged for their urgency and the community shares the same number as the physicians. Emergent calls to or from a consultant may be delayed due to this process.

#### **BACKGROUND**

The implementation of a phone tree will help eliminate some of the burden and delays faced by the current process. Physicians and offices that call the ED could be educated on how to quickly navigate the phone tree and calls from inside of the ED and hospital can be referred to a direct number without the phone tree.

#### **ASSESSMENT**

The phone tree will help triage the emergent calls and will help guide the calls to the correct recipient. In the future the phone tree can be used to also utilize Lead nurses, Physician Assistants, Medical Doctors, MICN Ask-A-Nurse Line and respective voicemails. Callers will be promptly guided in the direction and timing appropriate to their needs.

#### RECOMMENDATION

This scenario will ensure emergent calls are prioritized and prevent delays in patient care. This will also ensure patient, family and community calls are ushered expediently in the right direction. By proper use of the phone tree, the volume of calls going through the US will be markedly diminished and clinician interruption minimized. This will further reduce unnecessary and interrupting volume of overhead pages in the ED.
